Payments are processed on **Friday morning prior to the start of the following week**. Any changes to payment method need to be communicated by 6pm on Thursday, otherwise payment will automatically be processed. If payment is past due by one week, there will be a late fee of \$20. We can no longer accept charges on a card that are less than \$50. Cash and check are acceptable in any amount. Returned check fees will be the responsibility of the payee. We do not accept American Express. If your child was scheduled for a certain activity or program and it is less than 24-hour notice of cancellation, payment is still required. We also need a 24-hour notice if your child is adding a day or there will be an additional \$10 fee added to payment due for that day.
