

Fab-YOU-Us Family Fun Center Full Release of Liability and Waiver Form

In consideration of being allowed to enter the Fab-YOU-Us Indoor Play Park/structure, Beam EyeClick Room, Studio, or to participate in any party and/or program at Fab-YOU-Us Family Fun Center located at 1420 Mineral Spring Avenue North Providence, RI 02904, the undersigned, on his or her behalf, and on behalf of the minor(s) identified below, acknowledges, appreciates, agrees, and is fully aware, of the risks and hazards in participating in any of the activities on the premises of Fab-YOU-Us Family Fun Center and further agrees as follows:

I agree for myself and/or the minor(s) listed below that we shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions for play and participation in any party, activity, and/or program at Fab-YOU-Us Family Fun Center and agree to pay for all damages to the facilities of Fab-YOU-Us Family Fun Center caused by myself or caused by the listed minor(s), who are my responsibility or in my care, that may be negligent, reckless, or cause willful actions to damage property or harm another participant or staff member of Fab-YOU-Us Family Fun center. In addition, if I observe any hazard during our participation, I will bring it to the attention of the nearest Fab-YOU-Us Family Fun Center employee or official immediately. I recognize and understand that there are certain inherent risks associated with use of the Fab-YOU-Us Indoor Play Park/structure, parties, activities, and/or programs and that risks of injury include, without limitation, scrapes, bruises, cuts, and even more serious injuries, such as paralysis or death. Moreover, for myself and the minor(s), who are my responsibility or in my care, named below, I fully accept and agree to assume all of these risks (including the risks arising from the negligence of other participants), and I assume full responsibility for personal injury to myself and the listed minor(s), who are my responsibility or in my care, and our respective heirs, officers, members, agents, employees, other participants, and sponsoring agencies for injury, loss or damage arising out of or related to our participation in any and all of Fab-YOU-Us Family Fun Center programs, activities, parties, and/or the use of the facilities of Fab-YOU-Us Family Fun Center. This waiver and release shall be binding and apply to all risks, known and unknown, even if resulting from negligent actions of other guests or employees of Fab-YOU-Us Family Fun Center.

Each participant must have a waiver form signed, either by them or if you are under the age of 18 years, then signed by a parent/legal guardian or designated representative by parent/legal guardian. If a waiver is not signed, the person will not be able to participate in Fab-YOU-Us Indoor Play Park/structure, parties, activities, and/or programs.

“Rules of Play” include and are not limited to (a) socks must be worn in all areas of the Fab-YOU-Us Family Fun Center except in the studio where sneakers, dance shoes, or bare feet are required for play depending on game or activity. Socks alone are not permitted at any time in the studio space due to slipping hazard.

(b) Adults must supervise their children, at all times, during drop in activity times, parties, and events where adults are required to attend with their child. Fab-YOU-Us staff and management will provide adequate supervision for children during drop off sessions, activities, and programs.

(c) Smoking of any kind or consumption of tobacco products is strictly prohibited in the facility or near any of the entrances to Fab-YOU-Us Family Fun Center.

(d) Any inappropriate conduct that unreasonably interferes with the use or enjoyment of the Fab-YOU-Us Family Fun Center is prohibited. Any foul, slanderous language, intimidating or offensive behavior that would hinder the enjoyment of the center for others may result in dismissal without refund.

When/if inappropriate behavior arises in a drop off situation, where a parent is not in the facility, the child will be removed from the activity and asked to sit in the office area with a staff member until a parent has been notified and arrives to them pick up.

(e) I understand that the Fab-YOU-Us Family Fun Center is not responsible for lost or stolen valuables or property from within the facility.

I represent that I am the parent or legal guardian of the minor(s) named below, who are my responsibility or in my care, or I have obtained permission from the parent/legal guardian of the minor(s) named below to execute this agreement on their behalf. I further represent that the participants are healthy and physically able to participate in any and all undertaken activities.
